9	The normal brake and emergency brake should be in proper working condition and fully operational.		
10	The registration number must be clearly written and visible on the vehicle.		
11	The side mirror should be well-maintained and in excellent condition.		
12	A fire extinguisher must be present in the operator cabin.		
13	The carrier should be in proper working condition.		
14	The front and reverse horns should be operational and in proper working order.		
15	A well-stocked first aid kit is available in the operator cabin.
