8	Is validation of the HVAC system carried out as per specified frequency?			
9	Has the filter cleaning and monitoring record of the dust collector been maintained and updated regularly?			
10	Are all daily monitoring records of the production area and other critical areas maintained properly?			
11	Is the cooling tower cleaning schedule available?			
12	Are all cooling tower cleaning records updated?			
13	Has the chiller operation log been regularly updated?			
14	Is the cleaning log sheet for the RO membrane up to date?			
15	Are all training records of personnel available?			
16	Are all thermostats properly calibrated?			
17	Are all ducts sealed properly?
